The ultimate objective of the Workshop, which was attended by decision-makers, technocrats, water experts and leading academics from Turkey, Syria, Switzerland, Germany and Holland, was to produce a much needed synthesis of academic works and technical studies that are conducted on the Asi River basin.
- International conference on *Women, Water and Peace in the Middle East,* which was convened at MEF campus on 18-19 March 2016 was co-hosted by MEF University, Istanbul and the Strategic Foresight Group (SFG), Mumbai with support from the Swedish International Development Agency, Stockholm. The meeting brought together 60 thought leaders and women opinion makers from Iraq, Jordan Lebanon and Turkey as key participants, including former Ministers, Members of Parliament, government officials, academics and editors of newspapers.
